Subject:-ECCS-100% live Export Module

Attention of all the stakeholders and Courier Companies is invited towards the instructions dated 20.07.2020 issued by the Additional Director General Systems, Mumbai informing roll out of Express Cargo Clearance System(ECCS), application for Courier export consignments.

2. In this context, it is to inform that the Express Cargo Clearance System (ECCS) has migrated from EICI Data Centre to CBIC Data Centre on 29.06.2020. In ECCS, the Import module is presently 100% live at the 3 ICT locations and the export module is 100% live at Mumbai ICT. However, the export module for CSB IV and CSB V is on pilot run at Delhi.

3. **It has been decided that Export Module shall be rolled out 100% , hence it is proposed to be rolled out Courier Shipping Bill V (CSB V) in Express Cargo Clearance System(ECCS) . starting from 04.08.2020 onwards.**

Thereafter, Courier Shipping Bill (CSB IV) shall be rolled out, after the system is stable which will be communicated in due course of time. All Concerned dealing with Export Consignment through Courier mode are required to file CSB V, online in ECCS, from 04.08.2020.

4. The procedure for export of courier shipments should be followed as prescribed under the Courier Imports and Exports (Electronic Declaration and Processing) Regulations, 2010 as amended, and other relevant provisions of the Act, and other Notifications, Circulars etc as notified from time to time.

5. All the Custodians and Authorized Couriers are hereby advised to provide the details of any flights to be registered in ECCS, by email to AccNct.Delhi@icegate.gov.in by 03.08.2020.
