Attention of all the stakeholders and courier companies is invited towards the Public Notice No. 07/2022 dated 17.03.2022 informing the implementation of Express Cargo Clearance System (ECCS), at Hyderabad Courier Terminal.

- 2. In this context, vide para no.11 of the above mentioned Public Notice, it was informed that the roll out of ECCS at Hyderabad ICT was planned to be done in a phased manner and the exports covered under Courier Shipping Bill (CSBIII) was launched.
- 3. The procedure for import of courier shipments should be followed as prescribed under the Courier Imports and Exports (Electronic Declaration and Processing) Regulations, 2010, as amended, and other relevant provisions of the Act, and other Notifications, Circulars etc. as notified from time to time.
- 4. All the custodians and authorized couriers are hereby advised to provide the details of all flights to be registered in ECCS to the Department.
- 5. Further, Assistant Commissioner of Customs, Courier Terminal has been nominated as nodal officer for better coordination in the matter. Any problem encountered may be mailed at iecthyd@gmail.com and also may contact on 8374566777.

- 6. All trade, courier companies, custodians and other stake holders are requested to give wide publicity to this Public Notice.
- 7. With regard to implementation of courier bill of entry (CBE-XI, CBE-XII, CBE-XIII, CBE-XIV) in ECCS, difficulty, if any may be brought to the notice of the Joint Commissioner of Customs, Courier Terminal, Air Cargo Complex, Hyderabad.
