Subject: - Disaster Recovery Drill for ECCS application from 25.09.2020 to 27.09.2020

- 1. It is hereby informed that Directorate General of Systems, Central Board of Indirect Taxes and Customs (CBIC) would be conducting a Disaster Recovery (DR) Drill for ECCS application from 2200 hours on 25th September, 2020 to 0800 hours on 27th September, 2020. During this period, the ECCS application will be available for usual activities between 0800 hours to 2200 hours on 26th September, 2020. However, ECCS application would not be available for usage between 2200 hours on 25th September, 2020 to 0800 hours on 26th September, 2020 and between 2200 hours on 26th September, 2020 to 0800 hours on 27th September, 2020.
- 2. The main activities pertaining to the ECCS DR Drill are mentioned below:

2.1 Switchover

- i. Stopping of ECCS Application for Customs Officers and Custodians/Courier agency at Data Center (DC) Chennai at 2200 hrs. on 25th September, 2020.
- ii. Switchover of ECCS Application from DC Chennai to DC Delhi from 2200 hrs. on 25th September to 0600 hrs. on 26th September, 2020.
- iii. Availability of ECCS Application from DC Delhi for identified locations from 0600 to 0800 hrs. on 26th September, 2020.
- iv. Release of the Application for Customs Officers, Custodians and Courier agency for all locations from DC Delhi at 0800 hrs. on 26th September, 2020.
- v. Normal functioning of application from DC Delhi for all users from 0800 hrs. on 26th September 2020 to 2200 hrs. on 26th September, 2020.

2.2 Switchback

- i. Stopping of ECCS Application for Customs Officers and Custodians/Courier agency and officers at DC Delhi at 2200 hrs. on 26th September, 2020
- ii. Switchback of Application from DC Delhi to DC Chennai from 2200 hrs. on 26th September to 0600 hrs. 27th September, 2020
- iii. Availability of ECCS Application from DC Chennai for identified locations from 0600 hrs. to 0800 hrs. on 27th September, 2020
- iv. Release of ECCS Application for Customs Officers and Custodians/Courier agency for all locations from DC Chennai at 0800 hrs. on 27th September, 2020
- 3. The downtimes mentioned above may be taken into account by Couriers to plan the logistics in advance, so that the clearances are not affected during the DR Drill. The Customs field formations may consider requests for Manual clearances of courier consignments, specially for the time-sensitive export shipments.
