The Express Cargo Clearance System (ECCS) has migrated from EICI data centre to CBIC data centre on 29.06.2020. The ECCS application is owned and managed by CBIC, with M/s. Wipro being the application vendor and M/s. TCS being the infrastructure vendor. The office of WZU, Systems, Mumbai, has ensured the application related readiness for roll-out of ECCS at Jaipur International Courier Terminal. The infrastructure related pre-requisites should be ensured by the Custodians i.e. M/s. Rajasthan Small Industries Corporation Limited, M/s. Jaipur Gemstone Exchange. The following advisory is being issued for ensuring smooth and hassle-free roll out of ECCS at Jaipur ICT:

The users for accessing the main application portal will be created through the system by the Port Admin, RMS Admin and the respective Group admins (Courier Group Admin, Custodian Group Admin, Customs Group Admin). The user credentials will be received through an automated email. Upon first login, the users are advised to reset their passwords and set the Security Questions.
