## Sub: Advisory for Roll-out of ECCS at Ahmedabad ICT- reg.

The Express Cargo Clearance System (ECCS) has been successfully migrated from EICI data centre to CBIC data centres on 29.06.2020. The ECCS application is being owned and managed by CBIC, with M/s Wipro being the application vendor and M/s TCS being the infrastructure vendor. The office of WZU, Systems, Mumbai, has ensured the application related readiness for roll-out of ECCS at Ahmedabad International Courier Terminal. The infrastructure related pre-requisites should be ensured by the Custodian i.e. Gujarat State Export Corporation Limited. The following advisory is being issued for ensuring smooth and hassle-free roll out of ECCS at Ahmedabad ICT:

The users for accessing the main application portal will be created through the system by the Port Admin, RMS Admin and the respective Group admins (Courier Group Admin, Custodian Group Admin, Customs Group Admin). The user credentials will be received through an automated email. Upon first login, the users are advised to reset their passwords and set the Security Questions.

- 5. The roll-out of ECCS at Ahmedabad ICT is planned to be done in a phased manner. In the first phase, export document clearances under CSB III will be undertaken tentatively from 07.12.2020 on pilot basis for selected few flights, and will gradually be increased to 100% rollout. In the second phase, the export clearances under CSB IV and CSB V will be undertaken. In the third phase, the import clearances under CBE XI, CBE XII, CBE XIII and CBE XIV will be undertaken. The dates for last two phases shall be decided after successful launch of first phase and readiness of all stakeholders for the next phases. An experienced resource from Wipro will be deployed during the initial days for providing adequate handholding to the stakeholders.
- 6. A suitable Public Notice (draft attached) may be issued by your office for the benefit of all the stakeholders and adequate staffing of Customs officers for ECCS may be ensured.
- An online group has been created, including the WZU officers, Customs field formations, Custodians, authorised Couriers, Wipro, PWC and TCS, to ensure fast communication, to address the ECCS roll-out related issues.
