Sub: Integration of ECCS with IDPMS / EDPMS of RBI- reg.

- 1. This advisory is issued in continuance to earlier Advisory No. 05/SYS/WZU/2021 dated 20.07.2021 and Advisory No. 06/SYS/WZU/2021 dated 26.07.2021, issued on the above subject.
- 2. In order to further enhance 'Trade Facilitation' and ensure 'Ease of Doing Business', the integration of ECCS with IDPMS / EDPMS of RBI was planned to be launched in a phased manner. This integration will assist the exporters and importers to ensure online and hassle free compliance of Foreign Exchange Management Act, 1999 and Foreign Exchange Management (Current Account Transaction) Rules, 2000. The Courier Bills of Entry (CBEs) and Courier Shipping Bills (CSBs) data shall be transmitted online from ECCS to RBI systems via ICEGATE.
- 3. The first phase of roll out of integration of ECCS with IDPMS / EDPMS of RBI was launched on 09.08.2021. After roll out of first phase, the data of CBE and CSB filed with AD code and its successful validation reveals that now most of stakeholders are compliant in this regard.
- 4. In view of the above, it is planned to share data with RBI in respect of documents with validated AD code status in ECCS from 01.11.2021 onwards. It is clarified that the processing of CBEs / CSBs shall not be stopped in ECCS, even if no AD code is provided or AD code is not registered in ICEGATE.
- 5. It is advised that all the exporters and importers should register their AD codes on ICEGATE. The importer or exporter, whose AD code is already registered in ACC location, having same port code as that of ICT, are not required to get themselves separately registered. The personal import / export shall also be exempted from AD code registration in ICEGATE.
