During this period, the ECCS application will be available for usual activities between 10 am to 11 pm on 11th March 2024. However, it would not be available for usage between 11 pm on 10th March 2024 to 10 am on11th March 2024, as well as from 11 pm on 11th March 2024 to 10 am on 12th March 2024.
